Our advice

Always check...

- banknotes showing wear and tear and those received in poorly lit places
- several security features don't rely on just one

If in doubt, compare the banknote with one you know to be genuine.

If you believe a banknote is counterfeit...

- do not pass it on it is a criminal offence to keep it in circulation
- have its authenticity verified at the nearest police station or a bank

Safe fan

If you believe you may be in danger, request assistance from:

- 999 emergency medical services
- 998 fire brigade
- **997** police
- 986 city guards

In case you forget the above numbers, you can always dial the emergency number: 112. The operator will put you through to the relevant emergency services. The emergency 112 number can even be dialed from a locked mobile phone (most models).

Keep your report brief and to-the point. Indicate:

- what happened (eg. a fight, theft, accident, assault or robbery),
- where it happened (note an address or a well-known landmark or characteristic point in the area).

Any connection with emergency number is free of charge, both from mobile phones and from public phones.

Sear in mind the risk of a terrorist attack:

- immediately to a security guard or a policeman,
- should a terrorist threat occur, follow instructions issued by the police and
- · do not leave your luggage unattended, so that it does not alert the police or security guards.

Bear in mind the key regulations concerning football supporters:

- security guards and club stewards are authorized to:
 - o verify entitlements of a person to attend a mass event; a person unable to demonstrate a relevant entitlement may be asked to leave the event,
 - o inspect documents of any person in order to ascertain their identity.
 - o screen any person through the use of a device for detecting metals and
 - o search luggage and clothing if they suspect a person possesses weapons or other dangerous objects such as explosives, pyrotechnical equipment, flammable materials, alcoholic beverages, abusive or psychotropic substances,
 - o issue discipline-enforcing instructions to people who violate public order or regulations of a mass event or trespass the event location, and if they fail to comply with the instruction, ban them from the venue,
 - o place under detention and hand over to the police, without delay, any person who causes a direct risk to goods or persons or a person who perpetrates forbidden acts.
- · A person who fails to comply with discipline-enforcing instructions issued by the security guards or club stewards or instructions issued by the police or the military police at the venue and at the time of the event is subject to a penalty of arrest and/or a fine of no less than PLN 2,000,
- Sale, servicing and consumption of alcoholic beverages of up to 3.5% is allowed only within specially designated zones on location,
- smoking is forbidden in public places, including (but not limited to) stadiums, bus stops, public transport vehicles, pubs and restaurants,
- children under 13 are admitted as spectators to a football match only if accompanied by adults (18 years of age or older).

- should you spot a suspiciously behaving person or unattended luggage, report it

Safe possesions

Beware of being an easy target! Pickpockets are especially active on public transport vehicles, in pubs, shopping malls and other crowded places, at stadiums and within fans' areas.

Keep your personal belongings secure:

- do not leave documents, money, electronic equipment etc. unattended (eg. in a car),
- do not carry documents and money in the pockets of your outer garments or in the back pockets of your trousers – keep them in a breast pocket or a zipped pocket.
- make a photocopy of your passport and other ID cards and leave them where you are staying,
- do not carry large amounts of cash on you (you may withdraw cash from ATMs and use your credit card).

If you become aware of a loss or theft of:

- valuables promptly refer to any policeman, city guard or security guard or report the event to the nearest police station,
- credit or ATM card block it forthwith, by calling your bank or credit card issuer hotline (confirm this number with your bank),
- passport ask your embassy for a replacement travel document.

Safe journey

You may reach the stadiums in a fast and easy manner by public transport vehicles. A ticket for tram, underground, bus services as well as a fast urban railway can be purchased at newsagents', selected stores, street ticket-vending machines or from a bus/tram driver. Train tickets may be purchased at the ticket offices at the railway stations or via the Internet

If you are going to drive a car, bear in mind that:

- the speed limit for a passenger car or a motorbike is:
 - o 50 km/h (31 mph) in built-up areas during the day (from 5 a.m. till 11 p.m.),
- o 60 km/h (37 mph) in built-up areas during the night (from 11 p.m. till 5 a.m.),
- o 90 km/h (56 mph) out of built-up areas.
- o 120 km/h (75 mph) on dual carriageway expressways,
- o 140 km/h (87 mph) on motorways.
- driving with dipped beam lights turned on (or daytime running lights) remains obligatory at all times,
- a driver and all passengers should keep their seatbelts fastened throughout the
- a child under 12 years of age and 150 cm (59.1 inches) must be carried in child restraints or another equipment for transporting children,
- a driver is not allowed to talk on the mobile phone which would require holding a receiver or a microphone in a hand while driving,
- it is an offense to drive a vehicle after consumption of alcohol or after taking substances which produce similar effects (state after the consumption of alcohol: BAC of 0.2 – 0.5 ‰ or 0.1 mg – 0.25 mg/dm³ concentration of alcohol in exhaled air),
- it is a crime to drive a mechanical vehicle in the state of intoxication or under influence of abusive substances (state of intoxication: BAC of above 0.5 %) or 0.25 mg/dm³ concentration of alcohol in exhaled air),
- a driver is required to carry the following documents and present them on request of authorized officers:
 - o driver's license.
 - o vehicle registration card,

 - o third party liability insurance.
